**NOTICE IS HEREBY GIVEN** that the Board of Directors of CCP Metropolitan District No. 1 (the “**District**”), City and County of Denver and Adams County, Colorado, will meet in special session on Tuesday, the 8<sup>th</sup> day of October, 2024, at the hour of 3:00 p.m. at the offices of Public Alliance, 405 Urban Street, Unit 310, Lakewood, Colorado 80228 and which such meeting will also be made accessible to the public via video or telephone conference (Zoom) as provided below.

At this meeting, it is anticipated that the Board will make a final determination to issue general obligation indebtedness in the form of a capital pledge agreement. Specifically, the District will consider adoption of a Resolution Authorizing the District to enter into a Capital Pledge Agreement with CCP Metropolitan District No. 3 (“District No. 3” and, together with the District, the “Districts”) and UMB Bank, n.a. for the purpose of providing debt service mill levy revenue to District No. 3 to fund the repayment of the General Obligation Limited Tax Refunding Bonds, Series 2024 anticipated to be issued by District No. 3 for the refinancing of indebtedness previously incurred by the Districts; approving the form of the Capital Pledge Agreement; authorizing the execution and delivery by the District thereof and performance by the District thereunder; and authorizing the execution and delivery of all documents, agreements and certificates in connection therewith.

The Board will also take up such other business as may be before the Board and will consider the items listed on the attached Agenda. The meeting is open to the public.

*Pursuant to the provisions of the Supplemental Public Securities Act, one or more members of the Board may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device.*
